MTV MUSIC SUBMISSION FORM: A TERRIBLE DEAL FOR ARTISTS, SONGWRITERS AND PRODUCERS

MTV's submission agreement represents almost the worst possible deal for any creator. It basically allows MTV or its sister networks including BET and VH1, to use your music or video for any conceivable purpose including in its many reality shows, promos or websites or any other program without paying you a penny.

Note that the form is part of MTV's terms of use, which hardly anyone reads.

This contract basically provides that you grant MTV the right to use your content "worldwide ... perpetual and royalty free," meaning they can use your music for any purpose without paying you anything forever.

Moreover, they don't have to even give you a credit. And they can make "derivative works" such as remixes without your permission.

Plus they can grant all these right to ANY third party!

They don't even allow you to receive royalties from your PRO when they use your music —instead they can register the song with their PRO as both the writer and the publisher and collect 100% of the public performance royalty. That means they can use your music in the background of a stupid reality show – so deep in the background that nobody notices – send their PRO a cue sheet *and get paid for using your music*.

Please read this User Content Submission Agreement carefully because it is a part of the <u>Terms of Use</u> <u>Agreement</u> and represents your legally binding agreement with us ("Submission Agreement") regarding your submission (and our display and distribution) of content to the Site via certain technology, functionality and/or features we make available to you so you can upload and post such content for display via the Site (collectively, the "User Content Submission Features"), and this Submission Agreement applies regardless of what type of Device you use to submit content to the Site. As the form states at the outset, you *should* read it carefully so you can learn just how horrible it is.

When you submit User Content, or by using or attempting to use the User Content Submission Features, you are signifying your agreement with and acceptance of all terms and conditions of this Submission Agreement as well as the terms and conditions contained in the <u>Terms of Use Agreement</u> that govern your legal and contractual relationship with MTV.

This means that whether you read this agreement or not, by simply uploading music to the site, you are agreeing to all the terms in the agreement. They are not even asking you to sign it.

We have the right to change the terms and conditions of this Submission Agreement at any time as described in our <u>Terms of Use Agreement</u>. If you do not agree with all the terms and conditions of this Submission Agreement at any time, including, without limitation, those times when we make changes, do not use, do not attempt to use, and immediately discontinue your use of, the User Content Submission Features, because if you do any of these things you are agreeing to be bound by all of the terms and conditions of this Submission Agreement, including, without limitation, any changes we have made.

IMPORTANT NOTE: You must meet the Age and Other Eligibility Requirements in Section 2of this Submission Agreement and each and every time you submit or attempt to submit User Content, among other things, you will be asked to confirm your compliance.

1. Submitting User Content.

The term "<u>User Content</u>" means and refers to any and all content, media and materials you submit for posting on the Site using the User Content Submission Features, including, without limitation, still photographs, writings, spoken statements, music, audio, video, video recordings, audio-visual works and recordings, slides, portraits, animated and/or motion pictures, caricatures, likenesses, vocal or other sounds, sound recordings, voices, voice reproductions, computer graphics and visual effects, as well as any accompanying documentation, packaging or other materials, tangible or intangible, and to all derivative works, translations, adaptations or variations of same, regardless of the tangible medium, broadcast medium, format or form, now known or hereinafter developed or discovered, and regardless of where produced, on location, in a studio or elsewhere, in black-and-white or in color, alone or in conjunction with other work, characters, real or imaginary, in any part of the world. User Content is also considered a "Posting", as such term defined in the <u>Terms of Use Agreement</u>, and therefore, all terms and conditions contained within the section of the <u>Terms of Use Agreement</u> entitled "<u>Postings</u>" shall apply to all User Content you submit pursuant to the terms and conditions of this Submission Agreement for Posting to the Site.

Each time you upload or submit User Content (or if you attempt to do so) you will be confirming your acceptance of, and agreement to be bound by, all the terms and conditions of this Submission Agreement. Instructions for uploading User Content can be found on the Site's web page for the upload of User Content. To be considered for posting and display to the public, User Content must meet all the

specifications and requirements relating to formatting, compatibility, operating characteristics and submission which can also be found on the Site's web page for the upload of User Content. In order to submit User Content, you will also need to meet our Age Requirements (see Section 2 below).

When you submit User Content you may also be asked to provide some information about you and your submission. This may include, without limitation, such things as a descriptive title, some information about the User Content, length, your location and/or similar information. By submitting User Content, you are also agreeing and you understand that the term "User Content" also includes, without limitation, and refers to all of the information you submit or we may receive that is related to your submission. Always keep a copy of anything you send because we are not responsible for lost, damaged, misdirected, unusable or unreadable User Content. Proof that you submitted User Content does not constitute proof that we received anything.

2. Age and Other Eligibility Requirements.

By submitting User Content pursuant to the terms and conditions of this Submission Agreement you are certifying that you satisfy the age and other eligibility requirements set forth in the <u>Terms of Use</u> <u>Agreement.</u>

Generally, click through agreements such as this state that children under the age of 13 should not use the site. But this doesn't mean that the terms of this dreadful agreement would not apply to a video or song uploaded by 12 year old.

3. User Content Standards; Unauthorized Content.

This paragraph basically allows MTV to delete your content; and makes you exclusively liable for any claims that may arise in connection with your content such as copyright infringement.

You are solely responsible and liable for your communications and submissions (and the consequences) made under your name, user name, email address, password and your registration and profile information, if any. User Content does not reflect the views of MTV, and neither MTV, nor any of the Parent Companies or the Affiliates, represents or guarantees the truthfulness, accuracy, or reliability of any User Content, or endorses or supports any opinions expressed in any User Content. In no event shall MTV, the Parent Companies or the Affiliates have or be construed to have any responsibility or liability for or in connection with any User Content. If we determine, in our sole discretion, you have not met the Age Requirements (see Section 2 above) or if, in our judgment, you or any User Content you submit violates this Submission Agreement, we reserve the right, at any time, without notice and without limiting any and all other rights we may have under this Submission Agreement, at law or in equity, to (a) refuse to allow you to submit further User Content, (b) remove and delete your User Content, (c) revoke your registration and right to use the User Content Submission Features and (d) use any technological, legal, operational or other means available to enforce the terms of this Submission Agreement, including, without limitation, blocking specific IP addresses or deactivating your registration, access using your e-mail address, your user name and password.

By submitting User Content, in addition to the rights, licenses and privileges referred to above, you are also granting MTV, the Parent Companies and the Affiliates, the unqualified, unrestricted, unconditional, unlimited, worldwide, irrevocable, perpetual and royalty free right, license, authorization and permission to use and refer to your name, logo, marks, image, characteristic or other distinctive identification in presentations, marketing materials, customer lists and financial reports, to do, perform, take advantage of and exploit any and all of the rights set forth herein in connection with the marketing, advertising and promotion of the Platforms, and any products, goods, features, functions, capabilities and/or services associated with MTV, the Parent Companies and Affiliates and to use and otherwise exploit any ideas, concepts, content, material, expression or form of expression, in whole or in part, contained in your User Content, for any purpose whatsoever, without any credit, compensation or accounting to you, in products or services developed by MTV, the Parent Companies and the Affiliates, without limitation or restriction whatsoever.

The rights, licenses and privileges described in this Submission Agreement and granted to MTV, the Parent Companies and the Affiliates, shall commence immediately upon submission of your User Content to or through the User Content Submission Features and continue thereafter perpetually and indefinitely, regardless of whether you continue or remain a registered user or not, unless and until terminated, in whole or in part, by MTV on notice to you. Notwithstanding the foregoing, you acknowledge and agree that neither MTV, nor the Parent Companies or the Affiliates, shall be required or have any obligation to

host, index, display, accept or use any submitted User Content (or take advantage of any or all of the particular rights and authorities granted or otherwise available) and MTV may, in its sole discretion, remove or refuse to host, index, display, accept, use or do anything at all with respect to any User Content. Once you submit or attempt to submit User Content you shall have no right to prohibit, restrict, revoke or terminate any of the rights granted to MTV or the Parent Companies or the Affiliates. You are not entitled to and you will not receive any compensation or other consideration for your User Content or any use made of your User Content once submitted. You also understand and agree that neither all or any portion of your User Content, nor any commercial, advertisement, promotional, marketing or other material associated with your User Content, need to be submitted for approval prior to use.

You hereby release MTV, the Parent Companies and the Affiliates from any and all claims of any rights, encumbrances, liens, claims, demands, actions or suits which you may or can have in connection with your User Content, including, without limitation, any and all liability for any use or nonuse of the your User Content, claims for defamation, libel, slander, invasion of privacy, right of publicity, emotional distress or economic loss. MTV, and the Parent Companies and the Affiliates, have the right to assign, transfer, convey, license, sub-license and otherwise transfer, sub-contract, delegate, outsource or engage third parties to perform or benefit from all or any portion of its or their rights and/or obligations to any one or more other parties, without accounting, reporting, notification or other obligation or liability to you whatsoever, now or in the future. You also forever waive and relinquish all moral rights or droit moral now or hereafter recognized in connection with your User Content and the rights granted to MTV, the Parent Companies and the Affiliates hereunder.

MTV has the right to license, authorize and/or otherwise enter into agreements and arrangements with any Parent Companies or the Affiliates to do or perform any of the activities, exercise any of the rights and/or undertake any of the responsibilities granted or imposed under this Submission Agreement, in whole or in part. To the extent MTV does so, when you submit User Content each such Parent Company and Affiliate shall be entitled to exercise and benefit from the terms and conditions, rights, licenses and authorizations granted to MTV hereunder and related thereto as if you had entered into this Submission Agreement with such Parent Company or Affiliate directly.

6. Ownership.

The only fair thing in this agreement is that they don't try to get the copyrights in your work, but because they can grant any third party rights in your content they could effectively take away your ability to make money from your music or video.

MTV retains all right, title and interest in and to the User Content Submission Features, including, without limitation, to all associated intellectual property and proprietary rights existing anywhere in the world and you acquire no ownership, proprietary or other rights, title or interest in or to the User Content Submission Features.

Except for the licenses, authorizations, consents and rights granted hereunder and described in this Submission Agreement, as comprehensive and broad as they may seem or actually be,MTV acquires no title or ownership rights in or to any User Content you submit and nothing in this Submission Agreement conveys to us any ownership rights in your User Content. MTV is acting only as a host, bulletin board or conduit for submitted User Content, with all of the specific rights granted by you hereunder. Although by your submission of any User Content you are requesting and directing us and any of the Parent

Companies or the Affiliates with whom we have made arrangements, to take advantage of and exploit all of the rights and privileges granted hereunder (including, without limitation, the right to display and post the User Content on the Platforms), neither we, nor any of the Parent Companies or the Affiliates have any obligation to do any of these things.

You must own the rights to the User Content you submit and the right to grant all of the authorizations, permissions, approvals, consents, rights and licenses as described in this Submission Agreement. If you do not exclusively own all of these rights, you must have all necessary authorizations, permissions, approvals, consents, rights and licenses from the owner(s) to enter into this Submission Agreement and perform and comply with all of its obligations. 8. Indemnification.

If any one does make a claim against your music or video, this paragraph states you are exclusively responsible for dealing with that claim.

Your indemnification obligations under the <u>Terms of Use Agreement</u> include, without limitation, any third party claims arising from, related to or caused by your User Content, the submission of User Content and/or in any way associated with this Submission Agreement and/or the Site.

9. Disclaimers and Limitation of Liability.

THE USER CONTENT SUBMISSION FEATURES ARE PROVIDED "AS IS" WITH NO WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED AND YOUR USE OF THE USER CONTENT SUBMISSION FEATURES IS AT YOUR OWN RISK. YOU ARE SOLELY RESPONSIBLE FOR YOUR USER CONTENT, THE REPRESENTATIONS AND OBLIGATIONS UNDER THIS SUBMISSION AGREEMENT AND FOR ANY DAMAGES TO YOUR COMPUTER SYSTEM OR LOSS OF DATA RESULTING FROM YOUR USE OF THE SITE OR USER CONTENT SUBMISSION FEATURES. This User Content Submission Agreement was last modified on the date indicated above and is effective immediately.

Note, there are no signature lines. This is a "Click through" agreement meaning very few people read it. In fact, it is doubtful that anyone who actually noticed and read it would submit any music to MTV.
